## Stallion Service Agreement

**New Contract:**

The stallion fee is **\$950**. The stallion fee is due prior to the first semen shipment or the first insemination. If the breeding is not paid in full, semen will not be sent. Please enclose a copy of your mare's registration certificate and any genetic health panel results.

**Donated Contract: Association:** \_\_\_\_\_

The stallion fee is waived, and only the shipment fee **of \$475 for USA and \$650 for Canada** is due prior to the first semen shipment or the first insemination. Please include a copy of your completed payment to the auction in which you purchased your breeding.

**All Contracts in 2026 are for Frozen Semen.**

Each semen shipment is **\$475 for USA and \$650 for Canada**, and includes the return shipping label. Requests for semen shipments will be made by calling Oklahoma City Equine Clinic at (405) 843-1099. Bickell Ranches makes no representation or warranties, expressed or implied, regarding quality and characteristics of the frozen semen delivered under this agreement, and shall not be responsible for delayed, lost or mishandled deliveries. **Shipping fees will be payable directly to Oklahoma City Equine Clinic.** One dose per breeding will be sent unless otherwise agreed upon and noted in this contract. This contract is for one live foal. Any straws left over after a mare is confirmed in foal will be returned to Oklahoma City Equine Clinic. If the mare owner wishes to use the left-over straws on a second mare, an additional contract must be signed and all applicable fees paid. Neither Bickell Ranches nor any of its officers or employees shall be liable for damages as a result of damage to the semen or as a result of a mare failing to settle.

**Requests for semen shipments will be made by calling Oklahoma City Equine Clinic at (405) 843-1099. Please include your name, and the registered name of the mare you are breeding.**

A photo static copy of the registration papers on your mare must accompany this contract. The owner on record with APHA or AQHA will be recorded as the owner at time of breeding on the stallion breeding report.

This contract contains a "Live Colored Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, or a mare absorbs/aborts a predetermined pregnancy there are return privileges only if Bickell Ranches LLC is notified within thirty (30) days and receives a statement confirming this. A "Live Colored Foal Guarantee" will apply only to those mares that are certified in foal by a licensed, attending veterinarian. Confirmation of such pregnancy in the form of documented ultrasound picture or letter from the attending veterinarian must be received by October 1<sup>st</sup> of the breeding year. If a mare produces an offspring that is not eligible for Regular Registry with APHA, a rebreed will be offered for the following year only. Mare owner will be responsible for the rebreed fee.

If the mare absorbs or aborts a pregnancy after having been checked in foal, or if the mare fails to conceive during normal breeding season, the Mare Owner is entitled to rebreed for the following season only. There is a charge of **\$600** for rebreed service expenses which includes the first shipment of frozen semen. A substitute mare, accepted by Bickell Ranches, may be used if the original mare is deceased or deemed unfit for breeding by a licensed attending veterinarian. Bickell Ranches reserves the right to require a substitution if the mare fails to settle or is deemed unfit for breeding.

A Breeders Certificate will be issued for the foal conceived as a result of the breeding. The Breeders Certificate will be issued only after all expenses (including veterinary & recipient mare expenses) have been paid in full and after the foal is born and reported to Bickell Ranches. Mare owner agrees to complete the registration of the foal with APHA.

In the event that the stallion dies, is unavailable, or becomes unfit for service, this Agreement will immediately terminate. Bickell Ranches LLC shall have no liability to the Mare Owner except notification of its occurrence. Refunds of stallion stud fee (less collection and shipping charges) will be given at the sole discretion of the Stallion Owner. In the event that the mare dies during the breeding season, the Mare Owner may substitute another mare as may be agreed upon by both the Mare Owner and Bickell Ranches LLC.

When signed, by both parties, this document will become a legally enforceable contract binding both parties. The parties acknowledge that this agreement is made and shall be considered to be entirely performed within the State of Oklahoma and shall be construed and enforced under the laws of the State of Oklahoma. An equine professional is not liable for an injury or death of a participant in equine activities resulting from the inherent risk of equine activities.

This Agreement may be executed in one or more counterparts, each of which shall be deemed an original document, and all of which together shall constitute a single instrument. Facsimile or electronic versions of signatures, including e-signatures, will have the same force and effect as original signatures.
